The Parish Council had received three quotes for the grass cutting in the village on a 3 year contract from:

Stewart Bullard & Son Ltd - £663.00 + vat per cut for 2011 £696.00 + vat per cut for 2012 £730.00 + vat per cut for 2013

Buchans Landscaping & ground maintenance - £625.00 + vat per cut each year

CGM Landscapes Cambridge - £386 + vat per cut each year

It was **PROPOSED** to **RECOMMEND** to Full Council by Councillor Mrs P J Awbery-Maskell that the Parish Council use CGM at £386 + vat per cut for the next 3 years. providing they would agree to the following:
