2 PRESENTATION BY MR R SMITH – PLANS AT DERNFORD FARM

Mr R Smith gave a presentation to the Parish Council about their proposal at Dernford Farm

The proposal is called Cambridge Waterside and is an accommodation and leisure facility that is totally unique to this area. Based around a 35 acre lake, they are looking to develop a number of holiday homes to encourage both leisure and business based tourists to visit and stay in the Cambridge area.

They propose to incorporate a farm shop, an education facility and a nature trail into the scheme, with dipping ponds and interactive features, helping people to enjoy and learn about nature and conservation. The site will be rich in a wide variety of flora and fauna.

The development will incorporate various leisure facilities, such as sailing and windsurfing, a gymnasium and spa, a brasserie, tennis courts, an adventure playground for children, a separate lake with swimming and beach facilities, all of which can be enjoyed by both lodge guests and local people. They are also considering conference facilities for local businesses.

The Parish Council asked how many people they expect to visit and also the traffic movements as the entrance/exit will be onto the busy duel carriage way which has always been a concern of the Parish Council especially with cyclists. The traffic will obviously increase and the Parish Council would like something to be put in place for this before considering taking the proposal to the public for their views.
