7 20MPH SPEED LIMIT IN CHURCH LANE

It was explained that the cost to the Parish Council of placing a 20mph speed limit on this road would be in the region of £2K. It was suggested that may be a blanket order for the village could be applied for at this cost. Clerk to write to Mr M Cooper at CCC Highways for verification.

8 DOUBLE YELLOW LINES - CHAPELFIELD WAY

After a lengthy discussion it was **PROPOSED** to **RECOMMEND** by Councillor N Thomas and **SECONDED** by Councillor W A Fell to take no action at this time because of costs and not being able to enforce this.

It was also pointed out that it would be detrimental to the elderly residents not being able to park outside their property.

9 PUBLIC NOTICEBOARD

It was confirmed that Gravelles/Budgens would purchase and fix a noticeboard to the wall of their property in Selsingen Way. They felt that a free standing noticeboard with doors fixed on the boundary of their property in the gravel area would cause an obstruction when the doors were opened.

It was **PROPOSED** to **RECOMMEND** by Councillor Miss S E Clarke and **SECONDED** by Councillor J W D Reynolds to **ACCEPT** their kind offer.

It was also requested that they confirm in writing to the Parish Council and they will be donating this noticeboard to the village. This would then allow the noticeboard to go ahead without planning permission.

Car Wash - Common Lane

It was reported that a resident had approached the Parish Council to ask if the football played on Sunday could be played earlier or postponed until after the parade as a mark of respect. It was pointed out that this would be difficult as times were set by the F.A.

It was suggested that may be the parade route could be changed to avoid the football pitch. As it was too late for this year it was *AGREED* to investigate this matter further ready for next year.

Bonfire Night Posters

It was reported that although the posters were large enough for motorists to see the main heading it was impossible to read the rest of the information due to the typeface used. It also did not advise the location of the Event.

Manhole cover outside Gravelles/Budgens

It was reported that this had been repaired, but due to vandalism the notices had been removed before the surface had hardened leaving the area in its original state before repairs were carried out.
