### 7 RISK ASSESSMENT

The Clerk recently invited a Company to quote for completing a Health & Safety/Risk Assessment on all three Pavilions and the Office. (This is a Health & Safety requirement by law). It was explained that they will come and visit each area and create a report which will show us which areas may need attention. There is also an internal training program for the Staff which is included in the price. Each member of staff can complete each 20 minute training module and receive a certificate if passed. The Parish Council will also have access to a 24 hour advice line.

After lengthy discussion it was **PROPOSED** by Mrs S A Hatton and **SECONDED** by Dr D R Bard to **RECOMMEND** to Full Parish Council that we have Abbey HR to do our Risk assessments at the Office and the Pavilions at a one off cost of £4,268.00.
