7 CCC ROAD SAFETY SCHEME (NORTHERN JUNCTION ON SAWSTON BYPASS)

Mr Chabot explained that the CCC was proposing an Accident Reduction Scheme on the A1301 Cambridge Road to Sawston.

The proposed Accident Reduction Scheme consisted of traffic signals at the junction with a pedestrian crossing across the A1301 and a second crossing across the side road. The scheme would also include extending the existing cycleway so that it joined up with the new crossing points and resurfacing throughout the junction.

The Parish Council discussed this at length and although in principle they agreed with the scheme there were some concerns which are listed below:

- Coming from Sawston to the A1301 is a blind on the bend
- The Parish Council would support a one crossing solution, then people would cross at one point

- The Parish Council felt the speed limit of 50mph was too high where there would be traffic lights
- If the speed limit reduction was rejected could any other means of slowing the traffic down, i.e. rumble strips be recommended
