#### 15 - Benches: Deal Grove and Lynton Way

Councillor E C Murray advised that he had received very favourable reports regarding the new benches installed at Lynton Way and Deal Grove.

#### 5 SPORTS CLUB MATTERS

It was reported that at the last Sports Council Meeting held on 2 September 2013 it was decided not to meet bi-monthly due to lack of support, but meet only when issues needed to be discussed. Sports Clubs would be welcome to attend the Parish Council's monthly Recreation & Open Spaces Committee Meetings. At the present time it was also reported that no Sports Council Chairman had been elected.

#### **6 GROUNDSMAN ISSUES**

Mr A R Poole reported that he had been to Lynton Way Recreation Ground prior to the meeting as it had been reported to him that the floodlights keep tripping out. He advised Sawston United that it was the Club's responsibility and that they cannot be used until they have been fully checked by an electrician.

#### **Spicers**

Councillor K Cuffley mentioned his concerns if the away teams leave changing rooms in a dirty and untidy state how can we address this situation. It was suggested that the F.A. could become involved by writing to the Clubs but it was felt to be inappropriate.

#### Mill Lane

It was reported that dogs were running free and causing a nuisance. It was discussed and felt that instances needed to be reported to the Office with dates and times before the Police could be informed.

### **Lynton Way**

Mr A R Poole reported that the W.C. in the away changing room at Lynton Way Pavilion was leaking. He was asked to report this to the plumber when speaking to him about another matter at Spicers Pavilion.
