6 GROUNDSMAN ISSUES

Again it was discussed about the state the Pavilion was being left in and pictures were shown to the Council. Also the main door to the Pavilion and the garage door had been left open overnight. As these were reported straight away the culprits were easily identifiable.

This was discussed and it was *PROPOSED* to *RECOMMEND* to Full Council by Councillor R M Richmond and *SECONDED* by Councillor Dr D R Bard to fine Sawston United 1st team £25.00 for leaving the main door open and £25.00 for leaving the garage door open. If anything had been stolen during this time then the Club would have been liable as the Parish Council insurance would not cover this. Clerk to also ask them to send a representative to the next Recreation & Open Spaces Committee Meeting to explain why this happened.
