# 5 PLANNING APPLICATIONS AND ASSOCIATED MATTERS

The Chair agreed to deal with planning application S/1882/16/FL first to allow a presentation by the representative from David Osborn Architects.

It was *proposed* by Councillor Richmond and *seconded* by Councillor Grayston to suspend Standing Orders to allow the representative of David Osborn Architects to supply additional information about Planning Application S/1882/16/FL relating to 38 Woodland Road.

VOTE: 8 FOR : 0 AGAINST (UNANIMOUS)

Ms Bonner informed the meeting that the previous application had been supported by Sawston Parish Council and then rejected by SCDC. To deal with SCDC's issues the size of the annexe has been reduced by 20% and the footprint also reduced. The building has been re-sited in line with the existing garages away from the green belt. In addition, it is now a more traditional design, using traditional materials. Ms Bonner said that previous comments demonstrated concern about it being a separate dwelling however it does not have a kitchen and the siting means it cannot be accessed without crossing the main dwelling's garden. Previous objections from neighbours were concerned with the disruption caused by construction traffic. No objections to this application are showing on the SCDC website. Ms Bonner confirmed that David Osborn Architects has informed the neighbours about the new plans. When questioned Ms Bonner confirmed that the height had been reduced slightly.

The Chair thanked Ms Bonner for her input.

It was **proposed** by Councillor Grayston and **seconded** by Councillor Richmond to reinstate Standing Orders to allow the meeting to continue.

# 9 COUNCILLORS ISSUES AND AGENDA ITEMS FOR NEXT MEETING

# Issue 1

Councillor Reid suggested having a 'live' action list for each committee meeting as he is concerned that issues are raised and there is no record of them being followed up and/or resolved.

#### Issue 2

Councillor Reid said that the briars along the footpath in Mill Lane are a hazard to users of the footpath.

#### Issue 3

Councillor Grayston asked what the rules are relating to posters being displayed, specifically on the fence around the old Barclays bank site.

**ACTION:** The Clerk will report the large poster to SCDC Planning team.

#### Issue 4

Councillor Richmond asked if there was any news on the new tenants of the old Woodhead Publishing premises. There is no information in the public domain.

#### Issue 5

Councillor Matthews said he had been approached again about the ivy overhanging Hammonds Close causing problems for cars coming out onto the High Street.

**ACTION:** The Clerk will write another letter to the resident.

#### Issue 6

Councillor Matthews said the hedges are impinging on the footpath along London Road close to Park Road. Councillor Cuffley explained that responsibility for cutting these hedges back is unclear.

**ACTION:** The Clerk will find out if our County Councillor is aware of who is responsible

for maintenance of these hedges.

#### Issue 7

Councillor Matthews asked when the new pedestrian crossing on Babraham Road is expected to be started.

**ACTION:** The Clerk will get an update from our County Councillor.

#### Issue 8

Councillor Cuffley informed the meeting that the Planning team at SCDC confirmed the colour scheme of the Greyhound public house is within the prescribed list.

# Issue 9

Councillor Cuffley confirmed that his investigations have confirmed that the conservatory at Hutchings & Harding is listed and is included in the main building. It is also thought to be the only one of this design in the country.

# Issue 10

Councillor Martin asked that the fly-tipping behind the garages in Woodland Road be reported to the Environment team at SCDC.

**ACTION:** The Clerk will report this.

#### Issue 11

Councillor Martin reported that the triangle of grass in St Mary's Road is very overgrown and asked who was responsible. Councillor Cuffley thought it was the responsibility of the residents. Councillor Martin asked for the Clerk to confirm this before any action is taken.

**ACTION:** The Clerk will investigate.
