### 7 CONSIDERATION OF PURCHASE OF THE KINGS HEAD PUBLIC HOUSE

The Parish Council has been informed by SCDC that the owner of the Kings Head has given the council notice pursuant to section 95(2) of the Localism Act 2011 of their intention to enter into a relevant disposal of the asset. The Parish Council has been asked to express an interest if they feel there is a community interest in this pub and there is a 6-week interim moratorium that will end 17<sup>th</sup> July 2017.

This was discussed and it was **proposed** by Councillor Brian Milne and **seconded** by Councillor Neil Reid to **recommend** to full that we register an interest and advertise to see if there is any interest from community groups in the village.

#### 8 NEIGHBOURHOOD PLAN

Councillor Janet Martin confirmed the Neighbourhood Plan group has had a stall at the village fete, Mary Challis and the Church fete and has had a good response.

50 people in total have filled in the survey form

49 support the idea of a Neighbourhood Plan

48 are in favour of a joint Neighbourhood Plan with Pampisford and Babraham.

2 were not in favour although they did not provide a reason

30 people are keen to help

The possibility of a public meeting at the end of September was discussed. The Clerk will check the availability of the Henry Morris Hall at the village college.

### 11 COUNCILLORS ISSUES AND AGENDA ITEMS FOR NEXT MEETING: CONCERNING P & E ONLY

Councillor David Bard explained that Uttlesford has put in their submission for the local plan which includes 3 garden settlements, one in Great Chesterford which would have an impact on Sawston and surrounding villages. There is also concern that the consultation period starts 12 July – 29th August of which 4 weeks will be during August when Parish Council's do not meet and people are on holiday. It was agreed to draft a letter to Uttlesford Council to request an extension to the consultation period with support from neighbouring Parish Councils.

It will be made an agenda item for July's Full Parish Council meeting to discuss.

The County Council has published the modification of the bus routes which includes the Citi 7 which will now go through Addenbrookes. Full details can be found on <a href="https://www.stagecoachbus.com">www.stagecoachbus.com</a>. It was noted that although the route has been rationalised for the journey to Addenbrookes and the City Centre, there was now no connection to Trumpington Park and Ride and Waitrose.

As a result of the rainfall today (27 June) there has been a lot of surface flooding throughout the village and the Clerk was asked to write to County Council to highlight the problem areas.
