Councillor Kevin Cuffley discussed a meeting he had at Icknield Primary School this morning regarding the Bellbird school being oversubscribed and Icknield being under subscribed this has been over looked for 3 years and Kevin is going to looked into this.

Councillor Kevin Cuffley has been speaking with Highways regarding the application submitted to resurface the roads at Princess Drive and the High Street. Unfortunately, the application got put incorrectly which is why the road has been resurfaced as you come into the village from Pampisford end.

Highways are going to re assess these two roads and are hoping to get back on track.

Councillor Kevin Cuffley explained the residents at Bridge End Cottage Stapleford are going to remove their hedge row and it is going to be replaced with fencing. The path is going to be expanded which will make the road slightly narrower and a reduced speed limit to 40 MPH has been suggested.

Councillor David Bard explained the lights down Tower Road and Church Lane this street lights have been order but unfortunately cant be fitted by Npower for 6-8 weeks.
